#### **eCONSULT WORKFLOW REMINDERS**

**Routine Dilated Retinal Exam (DRE)** 

#### As a reminder: Do not submit an eConsult referral authorization to Ophthalmology for routine DREs.

PCPs can advise their Diabetic Members on IEHP Vision Providers they can go to directly to arrange their DRE. Prior to rendering services, IEHP Vision Providers are required to obtain an authorization for a DRE by submitting a DFE/DRE referral on the Provider Portal during the time of service. A search of Vision Providers contracted with IEHP can be found at www.iehp.org.
