

68,524 eConsults!

Top 10 Specialties for RUHS eConsults in August



A total of **93 clinics** from RUHS, Inland Empire Health Plan (IEHP), and Arrowhead Regional Medical Center (ARMC) have processed **68,524 eConsults** since the start of the MCeI.

RUHS primary care clinics play a major role, having submitted **1,368 eConsults** this month, and **22,225 eConsults** since MCeI's genesis.



Your efforts are improving patients' access to appropriate care!

RUHS physicians received specialists' recommendations remotely and coordinated patients' care for **around one-third** of eConsults submitted for **Cardiology** and **Endocrinology** services!


By coordinating with 48 specialists via eConsult, **135 physicians at 20 RUHS & CHS clinic sites** were able to serve **1,366 patients** by gaining access to specialty advice or care.

Direct to Authorization (DTA): Your Go-To Quick Guide

As a PCP or PSC at RUHS, you may place and utilize DTAs in eConsult to bypass clinical dialog and proceed directly to authorization.

If a clinical dialog is still desired for any orthopedic, podiatry, or opthalmology services, standard eConsults with specialists are always available.

1). PCP Places an Order for DTA

The PCP places an Ambulatory eConsult Order in Epic for a Direct to Authorization (DTA) specialty service. There are three DTA options available:



- Ophtho Diabetic Retinopathy
- Orthopedic Fracture
- Podiatry Fracture
